They also said that an increase in strength in Germany would prevent the spread of communism in other parts of Europe, especially in the West. That obedience to German demands could help prevent another war. The Treaty of Munich provides an example of the relief that a portion of the land taken from Germany was to be returned. However, Germany violated the terms of the treaty by invading Czechoslovakia, and as a result, the war broke out.

Another factor that can be attributed to World War II was the failure of the League of Nations. This was founded in 1919 and was responsible for maintaining world peace. All the world nations would be a part of this union, and disputes between the member states would be resolved and negotiated by its governing body. However, the League of Nations failed at the end of World War II because it could not convince the warring nations to resolve their differences peacefully without war.

In addition to the effects of World War II, Adolph Hitler's actions have a profound impact on the war. Hitler had a vision of world domination, which led him to build a large army and army. He violated
